NEW COUNTRY 96.3'S "PET FOR A VET – LUKE COMBS DC FLYAWAY" CONTEST OFFICIAL RULES

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. <u>Text</u>: Listen to KSCS-FM weekdays from 5:30am CT through 9:59am CT, 10:00am CT through 2:59pm CT, and 3:00pm CT through 7:00pm CT during the Contest Period. The station will announce a different daily keyword during the Contest Period, send a text message with the announced keyword to 888-787-1963 during the Contest Period. All entries must be received within the day it was announced to be eligible. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number, per keyword announced. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Contest.

4. **Text Winner Selection.** On or about 10:00am CT on June 3, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the

terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.
