New Country 96.3's "Dylan Gossett Winning Week" Contest Official Rules

The Station will conduct the New Country 96.3's "Dylan Gossett Winning Week" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin at 7:00pm CT on May 28, 2024 and will run weekdays from 7:00pm CT until 11:59pm CT through 11:59pm CT on May 31, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

<u>Text</u>: Send a text message with the daily keyword announced between 7:00pm CT and 11:59pm CT each weekday during the Contest Period, spelled correctly, to 888-787-1963 during the Contest Period. All entries must be received by 11:59pm CT on May 31, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

- 4. **Text Winner Selection.** On or about 10:00am CT on June 3, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
