NEW COUNTRY 96.3'S "JOE NICHOLS – MELINDA'S HOT SAUCE HOTTEST SEATS IN THE HOUSE WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the **New Country 96.3's "Joe Nichols – Melinda's Hot Sauce Hottest Seats in the House Winning Week"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal.
