NEW COUNTRY 96.3'S "MORGAN WALLEN PRE-PARTY COUNTRY CLOSE UP" TEXT CONTEST OFFICIAL RULES

The Station will conduct the **New Country 96.3's "Morgan Wallen Pre-Party Country Close Up" Text** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59pm CT on July 21, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

4. **Winner Selection.** Each weekday during the Contest Period, at or about 10:00am, Station will select a minimum of one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period.
