NEW COUNTRY 96.3'S "MIDLAND 6/21 – MELINDA'S HOT SAUCE HOTTEST SEATS IN THE HOUSE WINNING WEEK" CONTEST OFFICIAL RULES

The Station will conduct the New Country 96.3's "Midland 6/21 – Melinda's Hot Sauce Hottest Seats in the House Winning Week" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility.
