## NEW COUNTRY 96.3'S "Text to Win Tickets: Cory Morrow (October 14-27, 2024)" Contest Official Rules

All entries must be received by 11:59pm CT on October 27, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
