NEW COUNTRY 96.3'S "POST MALONE + JELLY ROLL" TEXT CONTEST OFFICIAL RULES

The Station will conduct the New Country 96.3's "Post Malone + Jelly Roll" Text Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. 2. **Contest Period.** The Contest entry period will begin at 9:00am on November 19, 2024 and will run through 11:59pm CT on May 4, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

<u>Text:</u> Listen to the station each day during the Contest Period for any song by Post Malone or Jelly Roll. When the listener hears a song by Post Malone or Jelly Roll, send a text message with the full title of the song, spelled correctly, to 888-787-1963. All entries must be received by 6:59pm CT on May 4, 2025 to be eligible for a chance to win a prize. Seven (7) different songs will be played during the Contest Period.

Each song will be played a minimum of one (1) time during the Contest Period. Entries must be received by the end of the Contest Period to be eligible to participate in the prize drawing. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

Winner Selection. On or about 10:00am CT on May 5, 2025, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
