NEW COUNTRY 96.3'S "KEITH URBAN WINNING WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **New Country 96.3's "Keith Urban Winning Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days and whose immediate family members or household members have not won a prize from the Station in the last 30 days. - 2. Contest Period. The Contest entry period will begin at 9:00am CT on December 14, 2024 and will run through 6:59pm CT on December 15, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

<u>Text</u>: Listen to the station each day during the Contest Period for any song by Keith Urban. When the listener hears a song by Keith Urban, send a text message with the full title of the song, spelled correctly, to 888-787-1963. All entries must be received by 6:59pm CT on December 15, 2024 to be eligible for a chance to win a prize.

Each song will be played a minimum of one (1) time during the Contest Period. Entries must be received by the end of the Contest Period to be eligible to participate in the prize drawing. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

Winner Selection. On or about 10:00am CT on December 16, 2024, Station will select one (1) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure

to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.
