99.5 THE WOLF'S "FORT WORTH STOCK SHOW& RODEO" CONTEST OFFICIAL RULES

The Station will conduct the **99.5 The Wolf's "FORT WORTH STOCK SHOW & RODEO WINNING WEEKEND"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days and whose immediate family members or household members have not won a prize from the Station in the last 30 days. One (1) different keyword will be announced each hour during the Contest Period from 9:00am-9:00pm CT on Saturday and 10:00am-7:00pm CT on Sunday for a total of six (6) different keywords throughout the contest period.

Each keyword will be announced a minimum of two (2) times on Saturday and a minimum of one (1) time on Sunday during the Contest Period, for a minimum of three (3) times throughout the Contest Period. Keywords must be received by the end of the Contest Period to be eligible to participate in the prize drawing. Message and data rates may apply. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.
