#### NEW COUNTRY 96.3'S "DIERKS BENTLEY WINNING WEEKEND" CONTEST OFFICIAL RULES

# 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Each song will be played a minimum of one (1) time during the Contest Period. Entries must be received by the end of the Contest Period to be eligible to participate in the prize drawing.
